4. Applicants must be available to make a formal presentation throughout the month of November. Applicants must also be available to attend the FBI Parade and Graduation on Monday 12<sup>th</sup> of December 2016.
5. FBI Fashion College accepts no liability for any commercial loss or the failure of an applicant's business venture. Conversely, FBI Fashion College will accept no responsibility or remuneration if the recipient of the grant achieves commercial success in their business venture.
6. All applications will be judged by a panel of judges appointed by FBI Fashion College. The judges' decision will be final and no correspondence will be entered into.
7. The eligible applicant that is determined to be the best application will be declared the Winner. The Winner will be announced at the FBI Parade and Graduation on Monday 12<sup>th</sup> of December 2016.
8. There is one \$10,000 cash prize available, provided as a cheque.
9. The prize will be available to be redeemed by the recipient in February 2017 in person at FBI Fashion College premises.
10. Documentation for 80% of the total grant (\$8,000) must be provided to FBI Fashion College as proof of expenditure.
11. The Winner may be liable to declare the prize for taxation purposes and will be liable for any tax payable in respect of a prize. Eligible applicants should seek independent financial advice in relation to any tax payable on the prize prior to submitting an application.
